Commercial Circular No. 55 (G) / 2018

Sub: Clubbing of RRS -3 and RRS -4 with ADB assisted coal handling project of M/s Paradeep Port Trust served by Paradeep station.

Ref: SER's Circular No. 68(G)/2001 dtd. 27.08.2001 and this office Commercial Circular No. 172(G)/2007 dtd. 10.08.2007.

ADB assisted coal handling project of M/s Paradeep Port Trust (Alpha Code- PPAP and Numerical Code – 12121028) served by Paradeep station was notified open for handling of inward goods traffic and outward booking of coal on Through distance basis.

Now, it has been decided to club Rail Receiving Station 3 and 4 (RRS – 3 & RRS – 4) inside PPT with ADB assisted coal handling project of M/s Paradeep Port Trust (PPAP).

Henceforth, traffic from/ to RRS -3 & RRS -4 will be charged on through distance basis reckoning chargeable distance for PPAP i.e. PRDP + 8 Km. Permissible free time for handling traffic at RRS -3 & RRS – 4 will be EOL free time.

In case, any additional shunting operation is performed by Railway Locomotive inside the siding, necessary shunting charges will be levied as per extant rules.

All other terms and conditions of the circular under reference shall remain unchanged.

All concerned to note and act accordingly.
