Relevant extract of Railway Board's letter No. TCR/1078/2008/1 (Corrigendum No.- 01 to Rates Circular No. 17 of 2016) dated 22.03.2018 is reproduced below for information and necessary action:

Sub: - Operation of Merry-Go-Round (MGR) System by Railways.

Ref: - Rates Circular No. 07 of 2016 dated 23.03.2016 {CCM/ECOR's Commercial Circular No. 28(G)/2016 dated 28.03.2016} and Rates Circular No. 17 of 2016 dated 20.05.2016 {CCM/ECOR's Commercial Circular No. 67(G)/2016 dated 23.05.2016}.

1. In terms of Rates Circular no. 07 of 2016 dated 23.03.2016 and 17 of 2016 dated 20.05.2016; Scheme for Operation of Merry-Go-Round (MGR) System by Railways is operative up to 31.03.2018.
2. The matter has been reviewed. It has now been decided to extend the validity of the scheme beyond 31.03.2018 for a further period of one month i.e up to 30.04.2018.
3. All other terms and conditions stipulated in above referred rates Circulars shall remain unchanged.
