Sub:- Clarification regarding validation of Special Passes issued on medical grounds with break journey and longer route facilities in Duronto Express trains.

It has been brought to the notice of Board that endorsement regarding validity in Duronto Express trains with break journey and longer route facilities are not being made on the Special Passes issued on medical grounds. In this context, it may be noted that Special Passes issued on medical grounds including Sleeper Class passes are valid for travel in Duronto Express trains subject to the entitlement stipulated in Board's letter No.E(W)2009/PS5-1/30 dated 22.04.2013. The Railways are accordingly directed to make necessary endorsement on Second Class 'A' & Sleeper Class Special Passes issued on medical grounds for travel in Duronto Express trains in the entitled class and for availing break journey & longer route facilities permitted vide Board's letter of even number dated 02.05.2017.
