Commercial Circular No.05(G)/2017

Sub: Levy of Congestion Surcharge for traffic booked to Bangladesh.

Ref: Board's Rates Circular No.23 of 2015 circulated vide CCM/ECOR's Commercial Circular No.97(G)/2015 dated 13.07.2015.

1. In terms of Para 3.0 of Rates Circular No.23 of 2015, Congestion Charge on all traffic booked for Bangladesh is leviable @ 25% of the applicable Base Freight Rates.
2. The matter has been reviewed and it has been decided to withdraw the levy of Congestion Charge for Stone traffic transported from Eastern Railway to Bangladesh Via Darsans/Benapole, as a special case.
3. These instructions shall come into effect from 12.01.2017 and shall remain in force up to 31.03.2017.
4. All other details of the Rates circular under reference will continue to apply unchanged.
5. An appraisal report in this regard may be sent to Board's office by 15th of every month.
6. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.

All concerned to note and act accordingly.
