Sub: Opening of Greenfield Private Freight Terminal (PFT) of Container Corporation of India Ltd (CONCOR) served by Jaggayapalem station.

It is hereby notified for information and guidance of all concerned that the Greenfield Private Freight Terminal (PFT) of Container Corporation of India Limited (CONCOR) served by Jaggayapalem station over WAT division is notified temporarily open for goods traffic on through distance as a full rake handling point.

The Alpha Code of the PFT is "CCJS", & Numerical Code is **12328734**.

CONCOR will now be termed as Terminal Management Company (TMC) of the said PFT.

In this connection following instructions are issued for strict compliance.

- 1) The chargeable distance for the traffic booked from / to CCJS shall be reckoned as **JGPM + 3.52 Km** (Three decimal five two Km).
- 2) In case, any additional shunting operation is performed by Railway locomotive inside the PFT, necessary shunting charges shall be levied as per extant rules.
- 3) All rakes loaded from PFT shall be weighed at Simhachalam North (SCMN).
- 4) The traffic of CONCOR (TMC) and authorized users as notified by Railway shall only be handled in the PFT.
- 5) List of Commodities permitted at the PFT are as follows:
 - a) Inward : All except POL.
 - b) Outward : All except Coal and Coke under priority "C" and POL.
- 6) Consignment booked from and to PFT will be pre-paid.
- 7) All Commercial and Operating rules as applicable in a Goods sheds for booking, supply and delivery of goods shall be applicable at the PFT.
- 8) All charges, surcharges, cess, levies, taxes etc as per prevalent rules as notified from time to time will be payable by TMC in respect of PFT.
- 9) The said PFT will be governed as per extant PFT policy issued by Railway Board or as revised from time to time.
- 10) This notification is **valid upto 08.04.2017**.

All concerned to note and act accordingly.
