**Sub: Inflation in distance for charge between Bibinagar to Nadikude section of Guntur Division of South Central Railway.**

**Ref: Board's letter No.TCR/1099/87/6 dated 17.02.1989 followed by XXR Wireless No.TCR/1099/92/6 dated 28.07.1992.**

1. Please refer to Board's letter and XXR Wireless under reference regarding inflation in distance for charge between Bibinagar to Nadikude broad gauge line whereby inflation in the chargeable distance of 50% (fifty percent) between Bibinagar to Nadikude was inflated by 50% (fifty percent) with effect from 01.09.1992.
2. Matter has been reviewed and it has been decided to withdraw the inflation in distance for charge for all goods traffic on Bibinagar to Nadikude broad gauge line.
3. These instructions shall come into effect from 15.02.2017 and will remain in force till further advice.
4. This issues in consultation with Traffic Transportation Directorate and concurrence of Finance Directorate of Ministry of Railways


