**Sub: Permissible Carrying Capacity (PCC), Standard Rake Size and Loading Tolerance of BFNSM 22.9 Tonne type of wagon.**

(ii) Board's Rates Master Circular dated 14.07.2016 on Block Rakes/ Mini Rake/Two Point Combination etc and Corrigenda thereto circulated vide CCM/ECOR's Commercial Circular No.101(G)/2016 dated 15.07.2016 and Corrigenda thereto.

A proposal for fixation of Permissible Carrying Capacity (PCC) and standard rake size & minimum number of wagons required to be loaded for availing trainload benefit for BFNSM 22.9 Tonne type of Wagon was under consideration of Board.

The issue has been examined. It has been decided that for the purpose of charging BFNSM 22.9 Tonne type of Wagon may be treated as under:

Permissible Carrying Capacity (PCC) (refer Annexure I to Rates Master Circular / PCC/2015/0 dated 19.10.2015) shall be as under:

S.No.	Type of wagons	Excepted CC+8	Universalized CC+6	CC+8	Loading tolerance
26	BFNSM 22.9 T	63 T	65 T	67 T	1 T

The standard rake size and minimum number of wagons required to be loaded for availing trainload benefit (refer Annexure I to Rates Master Circular dated 14.07.2016 on Block Rakes/ Mini Rake/Two Point Combination etc) shall be as under:

S.No.	Type of wagons	Standard Rake Size	Minimum number of wagons to be loaded
16	BFNSM 22.9 T	58	57

These instructions shall come into force with effect from **13.04.2018** and shall remain in operation till further advice.

This issues in consultation with Traffic Transportation, Mechanical and Civil Engineering Directorates and with the concurrence of Finance Directorate of Ministry of Railways.
