**Commercial Circular No.100 (G)/2018**

**Sub: Exemption from mandatory weighment in case of low density commodities**

Ref: Rates Master Circular/Weighment/2014/0 and its corrigendum & addendum

(Circulated vide this office Commercial Circular No.84(G)/2014 dtd.14.07.2014 and corrigendum there to)

Please refer to Para 3.0 of Rates Master Circular under reference regarding exemption from weighment.

The matter has been reviewed and it has been decided to permit exemption from weighment to wagons loaded with low density commodities namely Petroleum Coke and/ or Metallurgical Coke by incorporating an additional Para 3.4 in the afore-said circular as under.

**“ 3.4. Dispensation from weighment in the case of Petroleum/Metallurgical coke.**

Dispensation from mandatory(100%) weighment of wagon/rake loaded with Petroleum Coke and/or Metallurgical Coke may be permitted with a proviso that at least 5% of rakes should be subjected to weighment. While permitting this exemption, it may be ensured that no commodity in any form other than these commodities is loaded in the wagon/rake.”


These instructions will be effective from 26.05.2018 and will remain valid for a period of one year.

Zonal Railways will analyze the weighment data of the rake loaded with petroleum coke/metallurgical coke which are subject to random weighment on quarterly basis and furnish their remarks/recommendation.

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Ministry of Railways.

All concerned to note and act accordingly.
