Sub: - Traffic for the private siding of M/s. Jindal Steel and Power Limited served by Kerejanga station.



1. The revised list of permitted inward & outward commodities for the private siding of M/s. Jindal Steel and Power Limited (Alpha Code: JSPK & Numeric code: 12221474) served by Kerejanga station over Sambalpur Division was notified vide this office commercial circular No. 95(G)/2017 dtd. 20.06.2017.
2. Now, it has been decided to include Sinter in the list of permitted outward commodities for JSPK.
3. With this inclusion, the revised list of permitted commodities for the siding is as under :

Inward- Iron ore Fines, Iron ore lumps, Sponge Iron, Imported Coking Coal, Non-Coking Coal, Non- Coking Coal for coal washery, Dolomite & Dolomite fines, Lime Stone & Lime Stone fines, Quartzite, Quartz, Misc. Flux & Ferro Alloy, Cement , MS Slab , Iron Pellets, Pig iron and Hot Briquetted Iron.

Outward-Steel, Slag, Pig iron, Granshots, Lime Stone fines, Sponge Iron/DRI, Coal fines, Iron ore Pellets, Iron ore Fines, Sinter, Coal Tar, Gasification oil & Coke.
