Sub:- Issue of RR in the case of M/s. DPCL siding in ECoR


Please refer to Board's letter No. 2009/TCFM/18/32 dt. 20.09.2011 vide which it has been decided that in the case of traffic originating / terminating from / to the M/s. DPCL siding in ECoR, RRs will be issued in the name of consignor / consignee instead of the port authority. This instruction was extended up to 30.06.2016 vide Board's letter of even number dt.31.12.2015 [CCM/ECoR's Commercial Circular No.172(G)/2015 Dt. 31.12.2015].

The matter has been examined and it has now been decided that RR may be issued henceforth as a regular measure in the name of consignor/consignee instead of the port authority in the case of traffic originating/terminating from/to the M/s. DPCL siding.

This issues in consultation with Freight Marketing Branch of Commercial Directorate & Infra Directorate and concurrence of Finance Directorate of Ministry of Railways.

All concerned to note and act accordingly.


