### Commercial Circular No.92(GC)/2016

**Sub:** Revision of freight charges for transportation of all animals including wild animals & birds in Parcel vans and Brake vans.

**Ref:** Para 2.7 of explanatory notes of parcel tables of IRCA Coaching Tariff No.25 (Part-III).



In reference to para 2.7 of explanatory notes of parcel tables of IRCA Coaching Tariff No. 25 ( Part – III), Ministry of Railways have decided to revise the charges for transportation of all animals including wild animals & birds in Parcel vans and Brake vans and shall be charged uniformly at 'L' – Scale instead of Scale- 'L' + 25% irrespective of the category of trains. This revised rate shall be applicable upto 30.03.2017.

2. No Free allowance shall be permissible in case of booking of animals/birds as luggage.
3. Apart from above other charges like development charge, service tax etc shall be levied separately as per instructions notified from time to time.
4. Other terms and conditions for booking of animals including wild animals/birds will remain same.
5. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
6. This instruction will take effect from **15.07.2016**.

All concerned to note and act accordingly.
