- 1.0 In terms of Corrigendum No.04 to Rates Master Circular/FIS/2015/0 dated 30.06.2016 {CCM/ECOR's Commercial Circular No.94(G)/2016 dtd.30.06.2016}, Automatic Freight Rebate Scheme for Traffic Loaded in Traditional Empty Flow Directions is operative up to 30.09.2016.
- 2.0 The matter has been reviewed by Railway Board. It has now been decided to extend the validity of the Scheme beyond 30.09.2016 for a period up to 31.10.2016.
- 3.0 All other terms and conditions stipulated in Rates Master Circular/FIS/2015/0 {CCM/ECOR's Commercial Circular No.83(G)/2015 dtd.17.06.2015} as amended from time to time will continue to apply unchanged.
- 4.0 This issues in consultation with Traffic Transportation Directorate and with the concurrence of the Finance Directorate of the Ministry of Railways.
