Sub: Amendment to Policy guidelines on 'Comprehensive Parcel Leasing Policy'.(Corrigendum to Freight Marketing Circular No.05 of 2016).

Ref: Freight Marketing Circular No. 05 of 2016 issued vide Board's letter No.2015/TC(FM)/10/06 dated 15.06.2016.(This office Commercial Circular No.85(GC)Parcel/2016 dated 17.06.2016).

1. Amendment No. 6 to MCPLP was issued under Freight Marketing Circular No.05 of 2016 vide Board's letter No.2015/TC(FM)/10/06 dated 15.06.2016.
2. In para 2.2 of the above referred circular, Para 6.1 of FMC No.6 of 2014 has been modified wherein the mode of Security deposit is written as "FDR or DD in favour of Sr.DFM /FA&CAO". This may be read as "FDR or DD in favour of FA&CAO".
3. Zonal Railways, are requested to go through these policy guidelines carefully and follow the same therein strictly.
4. Zonal Railways, before executing agreements for Parcel leasing contracts, must ensure that necessary changes have been made in the agreement in accordance with this modified policy.
