Sub: Automatic Freight Rebate Scheme for traffic loaded in TEFD  
Ref: Railway Board's Rates Master Circular/FIS/2015/0 and Corrigendum thereto  
(CCM/ECOR's Commercial Circular No.83(G)/2015 and Corrigendum thereto)

- 1.0 In terms of Corrigendum No.5 to Rates Master Circular/FIS/2015/0 dt 30.06.2016 (CCM/ECOR's Commercial Circular No.83(G)/2015 dtd 30.06.2016), Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Direction is operative upto 31.10.2016.
- 2.0 The matter has been reviewed by Railway Board. It has now been decided to extend the validity of the scheme beyond 31.01.2016 for a period of one month i.e 30.11.2016 or till the introduction of new TEFD policy, which ever is earlier.
- 3.0 All other terms and conditions stipulated in Rates Master Circular/FIS/2015/0 dt 30.06.2016 (CCM/ECOR's Commercial Circular No.83(G)/2015 dtd 30.06.2016) as amended from time to time will continue to apply unchanged.
- 4.0 This issues in consultation with Traffic Transportation Directorate and with the concurrence of the Finance Directorate of the ministry of Railways.
