Sub: Automatic Freight Rebate Scheme for traffic loaded in TEFD
Ref: Railway Board's Rates Master Circular/FIS/2015/0 and Corrigendum thereto
(CCM/ECOR's Commercial Circular No.83(G)/2015 and Corrigendum thereto)

- 5.0 In terms of Corrigendum No.6 to Rates Master Circular/FIS/2015/0 dt 28.10.2016 (CCM/ECOR's Commercial Circular No.139(G)/2016 dtd 31.10.2016), Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Direction is operative upto 30.11.2016.
- 6.0 The matter has been reviewed by Railway Board. It has now been decided to extend the validity of the scheme beyond 30.11.2016 for a period of one month i.e 31.12.2016 or till the introduction of new TEFD policy, which ever is earlier.
- 7.0 All other terms and conditions stipulated in Rates Master Circular/FIS/2015/0 (CCM/ECOR's Commercial Circular No.83(G)/2015) as amended from time to time will continue to apply unchanged.
- 8.0 This issues in consultation with Traffic Transportation Directorate and with the concurrence of the Finance Directorate of the ministry of Railways.
