Commercial Circular No. 130 (G) / 2017

Sub: CONCOR'S Port Side Container Terminal at Paradeep Port served by Paradeep station.

CONCOR'S Port Side Container Terminal at Paradeep Port served by Paradeep station over KUR Division is hereby notified as independent booking point for both inward and outward handling of container traffic.

The Alpha code of the CONCOR'S Port Side Container Terminal inside Paradeep Port is "CNCP" and Numerical code is "12121071".

The chargeable distance for the traffic booked from/to the terminal will be reckoned from/upto the serving station Paradeep. For placement/drawnout of rakes to/from the terminal from/ to the serving station, Port locomotives will be utilized.

In case, Railway locomotive is engaged for placement and drawn-out of rakes, necessary shunting charges shall be levied on actual basis as per "All India Engine Hour Cost", notified from time to time. The shunting charges should be collected locally. Station Manager/Paradeep will maintain details of type & number of Railway locomotives utilized, time of deployment and intimate the same to CGS / PRDP for calculation and collection of shunting charges.

All concerned to note and act accordingly.
