Commercial Circular No.136 (G)/2017

Sub: Movement of Restricted Commodities in Import Containers in seal cut containers

- Ref: 1. Railway Board's letter No.2008/TT-III/73/8 dt 01.07.08 (this office Commercial Circular No.82 (G)/2008 dt 15.07.08)
2. Railway Board's letter No.2011/TT-III/73/9 dt 03.03.17 (this office Commercial Circular No.28 (G)/2017 dt 03.03.17)
3. Railway Board's letter No.2011/TT-III/73/9 dt 27.04.17 (this office Commercial Circular No.72 (G)/2017 dt 28.04.17)

Attention is invited to Railway Board's letter under reference (1), wherein at para 5.1 it was notified that Ores, Minerals, Coal and Coke will be the Restricted Commodities for movement by Containers.

Under reference(2), wherein approval of Railway Board was communicated for permitting movement of all types of Ores, Minerals, Coal and Coke in import containers only, which are transported purely under customs bond and seal, in partial relaxation to the stipulation at para 5.1 of letter under ref(1) .


Under reference(3), wherein approval of Railway Board was communicated for permitting movement of import containerized traffic of restricted commodities(Ores, Minerals, Coal and coke) at FAK rates , in seal cut containers, subject to the following conditions:

- i) The imported containerized cargo is moved in the same containers, after custom clearance, in which they have arrived customs bonded.
- ii) The SMTP detail can be relied upon by the goods clerk to verify the same.

The permission was valid till 04.09.17. The permission is now further extended for a period of one year i.e. from 05.09.17 to 04.09.18. Division shall continue to maintain the record of movement of such restricted commodities in import containers in seal cut containers for perusal and onward submission to Railway Board for review.

This issues with the approval of Traffic Commercial and Finance Directorate of Railway Board.

All concerned to note and act accordingly.
