

Sub:-Entitlement of various types of accommodation based on the revised pay scale recommended by the 7<sup>th</sup> Central Pay Commission.

Ref: SER's letter No. L/Housing Policy /Improvement/225 dated 16.05.2018

This is in reference to SER's letter quoted above.

It is advised that the level of pay scale recommended by the 7<sup>th</sup> CPC are corresponding to grade pay, as such the instruction issued vide Board's letter under reference still holds good. It is further advised that there has been no change in the entitlement of the railway employees for Railway accommodation. Eligibility of entitlement and eligibility to register for the waiting list of a particular type of quarter are two different issues, should be dealt with separately.
