
(Addendum to FM Circular no. 15 of 2018)

Sub: Reduction in carrying capacity of SLRD coaches.

Ref: Rly Board's letter of even no. dated 10.05.2018.

1. Attention is invited to FM Circular no. 15 of 2018, dated 10.05.2018, wherein instructions were issued in regard to reduction of carrying capacity of SLRD coaches from existing 05 tonne to 04 tonne.
2. Zonal Railways are seeking clarification regarding fixing of lumpsum leased freight per day in case of leased Parcel traffic and status of Tender notices that have been floated, opened or are under finalisation.
3. The matter has been examined in consultation with the Finance Directorate of Ministry of Railways, and it has been decided that in case of leased parcel traffic, Zonal Railways may take action as follows:
 - 3.1 **New Tender:**


Zonal Railways shall invite tenders as per the revised carrying capacity of a compartment of SLRD coach i.e. 04 tonne for all new tenders henceforth.
 - 3.2 **Existing Contracts:**
 - i. In case of existing contract, Zonal Railways may take action by invoking 'Alteration/modification provision of agreement' of respective lease contract agreement.
 - ii. Zonal Railways shall issue notice to the leaseholders regarding reduction of carrying capacity of SLRD that they shall be allowed to load the parcels upto the revised carrying capacity of 04 tonne in a compartment of SLRD coach with immediate effect, and their existing leased freight shall be revised on pro-rata basis.



- iii. Zonal Railways must ensure that, under no circumstances, leaseholders shall load the parcels beyond the revised carrying capacity of 04 tonne of a compartment of SLRD coach.

3.3 Letter of Acceptance (LOA) issued:

- i. The cases, where 'Letter of Acceptance (LOA)' for award of leasing contract has been issued to the party prior to issuance of this circular, Para 3.2 above shall be applied.
- ii. The cases, where 'Letter of Acceptance (LOA)' for award of leasing contract has not been issued to the party prior to issuance of this circular, Zonal Railways will cancel all such tenders and return the earnest money to the tenderers.
4. These instructions shall come into force with immediate effect.
5. This issues with concurrence of Finance Directorate of Ministry of Railways.
6. Zonal Railways may take necessary action accordingly and ensure strict compliance of the above mentioned instructions.


