In terms of Board's letter TC-I/2014/104/2 dt. 22.10.2014(Circulated vide CCM/ECoR Commercial Circular No.132(G)/2014 dtd. 24.10.2014), Board (MT) has decided that electronic registration of demand for wagons (e-RD) will be mandatory in case of sponsored traffic as detailed in Para 6.0 of Rates Master Circular under reference with effect from 20th November 2014.

"6.0 Procedure for submission and sanction of sponsored Traffic is given in Annexure-1. Electronic registration of demand for wagons (e-RD) is mandatory only for the sponsored traffic mentioned in Annexure -I with effect from 20th November 2014."


