
**Commercial Circular No.141 (G)/2014.**

Sub: Change in name of the Private sidings of M/s. Sterlite Energy Limited/ Brundamal (SEBD) as M/s. Sesa Sterlite Limited.

Ref: This office Commercial Circular No.143(G)/10 dtd. 23.09.2010 & No 85(G)/12 dtd. 28.08.2012.

- 1) It is hereby notified that consequent upon the approval of the scheme of amalgamation and arrangements by an order dated 03.04.2013 of Hon'ble High Court of Bombay at Goa and by an order dated 25.07.2013 of Hon'ble High Court of Madras, **Sterlite Energy Limited** have merged with **Sesa Goa Limited**.
- 2) Further, due to subsequent change of name from **Sesa Goa Limited** to "**Sesa Sterlite Limited**" on and from 18<sup>th</sup> day of September, 2013 as per the fresh certificate of incorporation, issued by Registrar of Companies, Goa, Daman and Diu, **the Private siding of M/s Sterlite Energy Limited, served by Brundamal station is hereby changed to be known as the Private siding of M/s Sesa Sterlite Limited.**
- 3) The Alpha Code - SEBD & Numerical Code – 12221471 of the siding shall remain unaltered.
- 4) All other terms and conditions of the commercial Circulars under reference shall remain unchanged.
- 5) This notification shall come into force with immediate effect.


