List of permitted commodities for the private siding of M/s. Jindal Steel and Power Limited(Alpha Code: JSPK & Numeric code: 12221474) served by Kerejanga station of Sambalpur Division was notified vide this office Commercial circular No. 75(G)/2014 dtd.24.06.2014.

- i) **Inward**— Iron Ore Fines, Iron Ore lumps, Imported Coking Coal, Non-Coking Coal, Non- Coking Coal for coal washery, Dolomite & Dolomite fines, Lime Stone & Lime Stone fines, Quartzite, Misc. Flux & Ferro Alloy, Cement & MS Slab.
- ii) **Outward**—Steel, Slag, Lime Stone fines, Sponge Iron/DRI and Coal fines (non-programmed coal, under priority 'D')


