Sub: Exemption from mandatory (100%) weighment in case of containerized Import traffic.

Ref: Board's letters No.TC-I/2006/109/6 Pt.3 dt. 17.06.2013 (Rates Circular No. 16 of 2013) and No. TC-I/2006/109/6Pt.3 dt 23.05.2014, CCM/ECOR's Commercial Circular No.75(G)/2013 dated 18.06.2013 and 64(G)/2014 dated 26.05.2014 respectively.


Please refer to Rates Circular No.16 of 2013 (CCM/ECOR Commercial Circular No.75(G)/2013) vide which dispensation from weighment in the case of containerized Import traffic was implemented on an experimental basis for six months and the same has been extended from time to time. In terms of Rates Circular No. 24 of 2014 {CCM/ECOR's Commercial Circular No.89(G)/2014 dated 24.07.2014}, this dispensation is valid upto 23.11.2014

The matter had been reviewed and it has been decided to extend the validity of instructions regarding dispensation from weighment in the case of containerized Import traffic for a further period of four months i.e. upto 23.03.2015.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of the Ministry of Railways.

All concerned to note and act accordingly.


