Sub: Inclusion of Coal Char / Kiln Waste in the Commodity List.

South Eastern Railway vide letters mentioned above has sought clarification regarding classification of Coal Char / Kiln Waste Char. The issue has been examined in consultation with Associate Finance & Traffic Transportation Directorate of Railway Board. It is advised that the commodity Coal Char / Kiln Waste Char may be charged at Composite Base Freight rate as per Para 1.4 of Rates Circular No.06 of 2008 {CCM/ECOR's Commercial Circular No.28(G)/2008 dated 20.03.2008}, also incorporated as Para 3.0 of guiding principles for classification and general rules for charging in IRCA Goods Tariff No.47, Part-I (Vol-II).
