Sub: Exemption from mandatory (100%) weighment in case of containerized import traffic.

Please refer to Rates Circular No. 16 of 2013 (Circulated vide CCM/ECOR's Commercial Circular No. 75(G)/ 2013 dtd.18.06.2013) vide which dispensation from weighment in the case of containerized Import traffic was implemented on an experimental basis for six months and the same has been extended from time to time. In terms of Rates Circular No.16 of 2014 (Circulated vide CCM/ECOR's Commercial Circular No. 64(G)/ 2014 dtd.26.05.2014), this dispensation is valid upto 23.07.2014.

The matter has been reviewed and it has been decided to extend the validity of instructions regarding dispensation from weighment in the case of containerized Import traffic for a further period of four months i.e upto 23.11.2014.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of the Ministry of Railways.

All concerned to note and act accordingly.
