Commercial Circular No.90(G)/2014

Sub: Notification of Base Freight rate for the purpose of granting rebate under LWIS on 53 BTAP wagons (01st rake out of 02 rakes) of M/s Utkal Alumina International Limited.

Commercial circulars under reference have been issued for transportation of Alumina in 53 BTAP wagons (01st Rake out of 02 rakes) procured by M/s Utkal Alumina International Ltd under LWIS, between loading point M/s Utkal Alumina International Ltd's private siding at Tikiri in WAT division (MUAT) and unloading points i) M/s Mahan Aluminium siding at Bargawan in WC Railway ii) M/s Aditya Aluminium Ltd's siding at Lapanga (MAAL) and iii) M/s Hirakud Industrial Works Ltd's siding (HIWS) served by Sambalpur

In commercial circular under reference (1) & (2) it was indicated that applicable Base Freight for the purpose of granting rebate under LWIS would be notified as and when unloading point "M/s Mahan Aluminium siding at Bargawan" is notified by WCR.

Now, CCM/WCR vide Advance Rates Notification No.55 of 2014 dtd.24.06.2014 has issued commercial notification for opening of the siding. Further, Railway Board vide letter No.2011/TC(FM)/4/7(Utkala Alumina) dtd.15.07.2014 have modified name of the unloading point from "M/s Mahan Aluminium siding at Bargawan in WC Railway" to "Private siding of M/s Hindalco Industries Ltd (Mahan Aluminium Smelter and Captive Power Plant) (HIMB) served by Bargawan of WC Railway". In this regard, M/s Utkal Alumina International Ltd has executed Supplementary Agreement No.FM/LWIS/UTKAL/BTAP/2012/1/SUPPL 02 dtd.24.07.2014 with this railway.

In the above context, table mentioned in Commercial Circular No.18(G)/2014 dtd.13.02.2014 and 39(G)/2014 dtd.08.04.2014 is hereby replaced with the following:

Point No.3 of Commercial Circular No.18 (G)/2014 dtd.13.02.2014 & 39(G)/2014 dtd.08.04.2014 is replaced with the following:

- 3 15% (fifteen percentage) freight concession will be granted for a period of 20(twenty) years for each loading of the subject rakes of SPW procured under LWIS operating between existing or new private terminal capable of handling the traffic in such Special Purpose Wagons in an approved closed circuits. The concession will be given in the RR itself. The above mentioned freight concession will be granted in each case on the Base Freight rate prevailing at the time of issue of commercial circular No.18(G)/2014 for the said wagons i.e, dt.13.02.2014, which is **Rs 1567.10 Per ton Ex-MUAT to HIMB, Rs.675.00 Per ton Ex MUAT to MAAL and Rs.640.40 Per Ton Ex-MUAT to HIWS or Base freight rate applicable at the time of booking, during the currency of the concession period of 20 years, whichever is lower**

All other conditions of CCM/ECOR's Commercial Circular No.18(G)/2014 dtd.13.02.2014, 39(G)/2014 dtd.08.04.2014 & 65(G)/2014 dtd.04.06.2014 will remain unchanged.

All concerned to note and act accordingly.
