In this connection, it is to state that guidelines contained in Board's letter No.TC-I/2005/301/7 Pt.D dated 21.05.2014 {circulated vide CCM/ECOR's Commercial circular No.62(G)/2014 dated 26.05.2014} were made applicable from 01.06.2014. These guidelines have been withheld with immediate effect till further orders vide Board's letter No.TC-I/2005/301/7Pt.D dated 12.06.2014 {circulated vide CCM/ECOR's Commercial circular No.68(G)/2014 dated 12.06.2014}. Since then, the guidelines prevailing prior to 1<sup>st</sup> June'2014 are applicable.

As far as the period between the above mentioned Board's letters is concerned, the guidelines mentioned in Board's letter No. TC-I/2005/301/7Pt.D dated 21.05.2014 are applicable.
