**Commercial Circular No.100(G)/2014**

**Sub:** Permission to Container Train Operators to access private sidings for handling and transportation of commodities in container trains.

**Ref:** Railway Board letter No.2009/TT-III/73/9 dt 10.12.2010  
{CCM/ECOR's Commercial Circular No.173(G)/2010 dtd.23.12.2010}

In partial modification of the Railway Board letter No.2009/TT-III/73/9 dated 10.12.2010 permitting Container Train Operators (CTOs) to access private sidings for handling and transportation of commodities in container trains, Board has now decided that instead of annual review, permission will now be given for a period of five years.

However, Railways will undertake periodical commercial audit once in six months and if any case of drop in rail co-efficient (traffic moved in wagons other than container trains) is detected 'or' any case of movement of third party cargo is detected, then such co-user permission given to the CTO to access private sidings will stand cancelled and further movement from any private siding by the concerned CTO will be restricted for one year.

This issues with the approval of Traffic Commercial (FM) Directorate of Railway Board.

All concerned to note and act accordingly.
