

Sub: Liberalised Wagon Investment Scheme (LWIS) – Freight Marketing Circular No.11 of 2011 dated 02.01.2012 {CCM/ECOR's Commercial Circular No.03(G)/2012 dtd.06.01.2012

1. Policy guidelines on Liberalised Wagon Investment Scheme (LWIS) were issued vide FM Circular No.11 of 2011 under Board's letter No.2009/TC(FM)/4/6 dated 02.01.2012.
2. Para 7.0 of the policy has been amended and may be read as follows:
7.0 MAINTENANCE OF WAGONS
 - 7.1 Maintenance of the wagon will be undertaken by IR on payment as per agreements to be executed with the investor.
 - 7.2 The haulage charges for moving the wagons in rake formation from a private terminal to the workshop/maintenance depot/train examination point of the railway administration and back to the loading point shall be borne by the railway administration.
3. These instructions will come into force with effect from 01.09.2014. Haulage charge recovered earlier till the issue of this circular (Railway Board's FM Circular No.14 of 2014 dtd.01.09.2014) will not be refunded. Haulage charges accrued upto 31.08.2014 should be recovered from the LWIS investors.

All concerned to note and act accordingly.
