3. THE REMAINING OTHER ORIGINATING TRAINS WHICH ARE NOT CLASSIFIED UNDER SCALE 'R' AND 'P' ABOVE SHALL BE CHARGED FOR BOOKING OF PARCEL AND LUGGAGE IN SCALE 'S'.

4. The above rates shall be applicable to non-leased parcel traffic booking through railway by various rail uses for transportation of their consignment through train service brake vans or parcel vans (non-leased).

5. For Rajdhani/Shatabdi/Duranto trains parcel rates would be 25% over the Scale 'R'.

6. Registered Magazines and registered New Papers will continue to be booked at concessional rates uniformly at 45% of Scale 'S' by all trains including Rajdhani trains.

7. The minimum freight for non-leased parcel vans (VPU/VPH/VPs) for which indent have been placed by the parties shall be at Scale 'P' even when attached by trains which come under the category of standard parcel service at Scale 'S'.

8. Charging of parcel and luggage traffic in newly introduced trains and trains running temporarily for a particular period to clear the extra rush such as Summer special, Puja special/X-Mas special and Holidays special etc. shall be charged as per FM Circular No. 13 of 2008 for booking of non-leased parcels and luggage as under :-

1.	Newly introduced regular Mail/Express Train.	Scale - P In the first year only.	Scale - L In the first year only
2.	Newly introduced regular Ordinary Passenger Train.	Scale - s In the first year only.	Scale - L In the first year only
3.	Summer Special, Puja Special, X-Mas Special, Holiday Special trains.	Minimum Scale - P	Scale - L

9. The revised classification of trains will be effective from 1.6.2018.

10. Steps should be taken to ensure that the staff fully understand these changes and implement them properly. Commercial Inspectors (CMIs) and Traffic Inspector of Account (TIAs) should be deputed for ensuring correct implementation of the instructions and the revised 'S' scale.


