Sub: Revised Special Freight Train Operator (SFTO) Scheme.


Ref: Freight Marketing Circular No.15 of 2013 issued vide Board's letter No.2012/TC(FM)/4/10 dated 24.06.2013 {CCM/ECOR's Commercial Circular No.79(G)/2013 dtd.28.06.2013}

- 1.0 Policy on "Special Freight Train Operator (SFTO) Scheme" was issued vide above referred Circular.
- 2.0 It has been decided to make following changes in the aforesaid policy/circular-
 - (i) Para 10.2 appearing at page 9 of aforesaid circular may be henceforth read as under -

For each loading of an SPW rake, freight rebate of 12% would be granted for 20 years on the freight rate prevailing at the time of booking.
 - (ii) Para 7.13 appearing at page 8 of the aforesaid circular may be read/re-numbered as 7.12.
- 3.0 This issues with the concurrence of Finance Directorate of Ministry of Railways.
- 4.0 This will come into force w.e.f,24.09.2014
