Sub: Revised Private Freight Terminal (PFT) Scheme.


**Ref: Freight Marketing Circular No.05 of 2012 dated 23.04.2012
{CCM/ECOR's Commercial Circular No. 37(G)/2012 dtd.25.04.2012}**

- 1.0 Please refer to Freight Marketing Circular No.05 of 2012 issued vide Board's letter No.2011/TC(FM)/14/14 dated 23.04.2012 wherein Revised Private Freight Terminal (PFT) Scheme was issued.
- 2.0 It has been decided to make following changes in Para 13.1 of the policy guidelines on "Private Freight Terminal (PFT)". Para 13.1 of the aforesaid Circular maybe read as under-

Para 13.1 - Unless otherwise specified by IR from time to time by suitable notification or any other means of communication, a PFT under this policy would be permitted to book and handle all traffic excluding programmed coal, programmed coke and iron ore. Outward loading of only non-programmed coal and coke is allowed. However, PFT may be permitted to handle outward iron ore or iron ore pellet traffic from PFTs on payment of additional fee of Rs. 5 crore by the PFT owner(s) as per FM Circular No.12 of 2008 {CCM/ECOR's Commercial Circular No.114(G)/08 dated 12.09.2008}
- 3.0 The above changes in the policy will come into force with immediate effect.
- 4.0 This issues with concurrence of Finance Directorate of Ministry of Railways.

All concerned to note and act accordingly.


