Commercial Circular No.128(G)/2014

Sub:Transportation of relief materials booked by various Government Organization/Aided by Government agencies by Coaching trains to Jammu Tawai/Udhampur for the flood affected area of Jammu & Kashmir –Raising the bills against Jammu & Kashmir Government.

To facilitate the transportation of relief materials booked by various Government Organization/Aided by Government agencies by Coaching trains to Jammu Tawai/Udhampur for the flood affected people of Jammu & Kashmir. Ministry of Railways as a special case have decided that the relief materials shall be booked free of cost and the bills for transportation cost shall be raised against the Government of Jammu & Kashmir.

The above shall be permissible as per the following terms and conditions:-

- (i) The consignment shall be booked by District Magistrate of the originating District and consigned to the destination to the District Magistrates/Relief Commissioners of the concerned districts of Jammu & Kashmir subject to the condition that the relief material so transported will be distributed among the people in the flood affected areas of Jammu & Kashmir.
- (ii) In order to ensure that consignors do not face problems in booking of the relief materials for flood affected region, nodal officers should be nominated by the concerned Zonal Railway. The scheme of free rail transportation of relief material along with the details of the railway nodal officers (with address, telephone numbers etc.) should be given wide publicity in media at the Railway stations.
- (iii) It should be ensured that states where elections are due, no political party or individual takes credit for this transportation.
- (iv) The consignment will be booked solely at owner's risk and no claim for any loss or damage to the consignments carried under this special arrangement will be entertained.
- (v) The transportation cost involved in carrying these relief materials shall be borne by Government of Jammu & Kashmir and therefore, special care may be taken by the originating Railway's Traffic Accounts office for proper maintenance of records /accounts of such free bookings for billing and claim reimbursement of the freight from the Government of Jammu & Kashmir.
- (vi) The above instruction shall be valid from 24.09.2014 to 23.10.2014.

This issues with the concurrence of the Finance Directorate of this Ministry.


