Commercial Circular No.133(G)/2014

Sub:Freight Rebate for traffic moved in 8 wheeler (LPG) wagons  
(BTPGL/BTPGLN) procured by the Oil Industry-M/s HMEL..  
Ref: Board's letter No.TCR/1644/91/4 dated 17.12.1991 and 14.02.1992.  
\*\*\*\*

1. In terms of Board's letter under reference, freight rebate of 14.5% was granted to Oil companies for movement of Liquefied Petroleum GAS (LPG) in BTPGL wagons procured by Oil Industry at their cost. This rebate was granted for next ten years w.e.f. 01.01.1992. On expiry of the period of 10 years, rebate of 1% was granted to the Oil Industries for next 10 years.
2. Matter has been reviewed and sanction of the Central Government is hereby accorded to extend the freight rebate of 14.5% or 1% (depending on the age profile of 8 wheeler wagons) admissible on LPG movement in BTPGL/BTPGLN wagons procured by Oil Industry to M/s HMEL on the same terms and conditions as applicable to Oil Industry.
3. It may be ensured that necessary modification in support of above may be done in agreement with Oil Industry.
4. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.

All concerned to note and act accordingly.


