

accepted by the Government – Post Graduate Allowance.

Consequent upon the decisions taken by the Government on the recommendations of
the Seventh Central Pay Commission relating to revision of allowances, the President is pleased
to decide that Medical Officers will be granted Post Graduate Allowance as detailed below:

Post Graduate Allowance

S. No.	Category	Revised Rates
1.	Railway Doctors up to the level of non-functional selection grade having <u>Post Graduate degree</u> qualification recognised under Indian Medical Council Act, 1956.	₹ 2250/- p.m.
2.	General Duty Doctors up to the level of non-functional selection grade having P G Diploma qualification recognised under Indian Medical Council Act, 1956.	₹ 1350/- p.m.

- The rates of this allowance will further rise by 25 percent each time DA payable on revised pay scales rises by 50 percent. The revised rates of the allowance shall be admissible with effect from 1st July, 2017.
- The terms & conditions as contained in para 1426 of IREC Vol.II (Sixth Edition – 1987, Second Reprint Edition – 2005), will remain unchanged.
