In supersession of orders contained in Board's Letters of even number dated 31.05.16 (RBE No. 57/2016) and 26.12.2017 (RBE No. 205/2017) and in accordance with the orders contained in the DoP&T's Notification No. GSR.767(E) dated 11.08.18 amending Clause (bb) under FR 56 of the Fundamental Rules, 1922, the provisions in respect of age of superannuation of doctors of the Indian Railways Medical Service and Dental Doctors under the Ministry of Railways are modified as stated in the Notification.

2. The age of superannuation of Doctors belonging to IRMS and Dental Doctors under the Ministry of Railways shall be sixty-two (62) years unless they exercise the option of posting to a Clinical post depending upon their expertise and experience, as decided by the Competent Authority in the Ministry of Railways from time to time, in case they desire to continue in their service upto the age of sixty-five (65) years.

3. The serving doctors belonging to IRMS and Dental Doctors under the Ministry of Railways who have already attained the age of 62 years or will be attaining the age of 62 years within 6 months from the date of issue of these orders may exercise their option as per the enclosed format within a period of 30 days from the date of issue of these orders. All other doctors would, in future, be required to submit their option not less than 06 months before their attaining the age of 62 years. The Railway doctors should furnish their option through the Personnel Branches of their respective Railway administrations.


4. The serving doctors who fail to exercise the option within the period specified above shall stand superannuated from service on attaining the age of 62 years or on expiry of the period of 30 days from the the date of issue of these orders, whichever is later.

5. Posting orders involving inter-Railway transfers and for those working in Boards office will be issued by the Railway Board. Orders of CMSs and CMDs in Zonal Railways who cross 62 years of age and opt to serve in a Clinical post and who are posted on the same Railway itself would be issued by the Zonal Railway administration themselves.



6. Copies of options exercised by the Railway doctors should be forwarded to the Board's office (Secretary's Confdl. Cell) for record and necessary action.
7. A list of administrative posts identified by the Ministry of Railways and designations of IRMS officers after 62 years is annexed (Annexure C).

9. These instructions may be brought to the notice of all doctors belonging to IRMS and Dental Doctors under the Ministry of Railways.



सा.का.नि. 767(अ).—राष्ट्रपति, संविधान के अनुच्छेद 309 के परंतुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए मूल नियम, 1922 का और संशोधन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात्:—

1. संक्षिप्त नाम और प्रारंभ.—(1) इन नियमों का संक्षिप्त नाम मूल (दूसरा संशोधन) नियम, 2018 है।

(2) ये राजपत्र में उनके प्रकाशन की तारीख को प्रवृत्त होंगे।

2. मूल नियम, 1922 के नियम 56 में खंड (खख) के स्थान पर निम्नलिखित रखा जाएगा, अर्थात्:—

“(खख) (i) चिकित्सकों के संबंध में अधिवापिता की आयु, जो —

(i) केंद्रीय स्वास्थ्य सेवा;

(ii) भारतीय रेल चिकित्सा सेवा;

(iii) आयुष और आयुष मंत्रालय के अधीन कार्यरत;

(iv) सशस्त्र बल चिकित्सा सेवा के महानिदेशालय के अधीन सिविलियन चिकित्सक;

(v) भारतीय आयुध कारखाना स्वास्थ्य सेवा के चिकित्सा अधिकारी;

(vi) स्वास्थ्य और परिवार कल्याण विभाग के अधीन दंत चिकित्सक;

(vii) रेल मंत्रालय के अधीन दंत चिकित्सक; और

(viii) भोपाल मेमोरियल हॉस्पिटल और अनुसंधान केंद्र में कार्यरत सामान्य ह्यूटी चिकित्सा अधिकारी, विशेषज्ञ श्रेणी के चिकित्सक और चिकित्सा संकाय शिक्षण,

से संबंधित हैं, बासठ वर्ष होगी जब तक कि वे अपनी विशेषज्ञता और अनुभव के आधार पर शिक्षण, नैदानिक, रोगी देखभाल, स्वास्थ्य कार्यक्रमों के क्रियान्वयन, सलाहकार और परामर्श कार्य सहित सार्वजनिक स्वास्थ्य कार्यक्रमों और कृत्यों के लिए तैनाती के विकल्प का प्रयोग करते हैं, जैसा कि सम्बद्ध मंत्रालय या विभाग में समय-समय पर सक्षम प्राधिकारी द्वारा विनिश्चय किया गया है, यदि वे पैंसठ वर्ष तक अपनी सेवा जारी रखने के इच्छुक हैं।



परंतु, अधिवापिता की आयु, केंद्रीय सशस्त्र पुलिस बल और असम राइफल्स के सामान्य ड्यूटी चिकित्सा अधिकारी उप-काडर तथा केंद्रीय सशस्त्र पुलिस बल और असम राइफल्स के विशेषज्ञ चिकित्सा अधिकारियों से संबंधित चिकित्सकों के संबंध में पैंसठ वर्ष होगी।

(ii) ऐसे सेवारत चिकित्सक, जो उपखंड (i) में निर्दिष्ट सेवाओं से संबंधित हैं जिन्होंने पहले से ही बासठ वर्ष की आयु प्राप्त कर ली है या राजपत्र में इन संशोधन नियमों के प्रकाशन की तारीख से छः माह की अवधि के भीतर बासठ वर्ष की आयु प्राप्त कर लेंगे, मूल (दूसरा संशोधन) नियम, 2018 के प्रारंभ होने की तारीख से तीस दिन की अवधि के भीतर शिक्षण नैदानिक, रोगी देखभाल, स्वास्थ्य कार्यक्रमों शिक्षण, नैदानिक, रोगी देखभाल, स्वास्थ्य कार्यक्रमों के क्रियान्वयन, जिसके अंतर्गत उपखंड (i) में विनिर्दिष्ट सलाहकार और परामर्श कार्य सहित सार्वजनिक स्वास्थ्य कार्यक्रमों और कृत्यों के लिए तैनाती के विकल्प का प्रयोग कर सकते हैं।

(iii) ऐसे सेवारत चिकित्सक जो शिक्षण नैदानिक, रोगी देखभाल, स्वास्थ्य कार्यक्रमों और कृत्यों जिसके अंतर्गत उपखंड (i) में विनिर्दिष्ट सलाहकार और परामर्शी कृत्य हैं, के संबंध में उपखंड (ii) में विनिर्दिष्ट अवधि के भीतर अपने तैनाती का विकल्प का प्रयोग करने में असफल रहते हैं, को बासठ वर्ष की आयु प्राप्त करने पर, या मूल (दूसरा संशोधन) नियम, 2018 के प्रारंभ होने की तारीख से 30 दिन की अवधि के समाप्ति पर इनमें से जो भी पश्चातवर्ती हो, सेवानिवृत्त हो जाएंगे।"

### NOTIFICATION

New Delhi, the 11th August, 2018

**G.S.R. 767(E).**—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the Fundamental Rules, 1922, namely :—

1. **Short title and commencement.**—(1) These rules may be called the Fundamental (Second Amendment) Rules, 2018.  
(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Fundamental Rules, 1922, in rule 56, for clause (bb), the following shall be substituted, namely:—

“(bb) (i) The age of superannuation in respect of the doctors belonging to—

- (i) Central Health Service;
- (ii) Indian Railways Medical Service;
- (iii) AYUSH and working under the Ministry of AYUSH;
- (iv) Civilian doctors under the Directorate General of Armed Forces Medical Service;
- (v) Medical Officers of the Indian Ordnance Factories Health Service;
- (vi) Dental Doctors under the Department of Health and Family Welfare;
- (vii) Dental doctors under the Ministry of Railways; and
- (viii) General Duty Medical Officers, Specialist Grade doctors and Teaching Medical Faculty working in Bhopal Memorial Hospital and Research Centre,

shall be sixty-two years unless they exercise the option of posting to Teaching, Clinical, Patient Care, Implementation of Health programmes, Public Health programmes and functions including advisory and consultancy depending on their expertise and experience, as decided by the competent authority in the concerned Ministry or Department from time to time, in case they desire to continue in their service upto the age of sixty-five years:

Provided that the age of superannuation in respect of the doctors belonging to the General Duty Medical Officers sub-cadre of Central Armed Police Forces and Assam Rifles and Specialist Medical officers of Central Armed Police Forces and Assam Rifles shall be sixty-five years.

(ii) The serving doctors belonging to the services referred to in sub-clause (i) who have either already attained the age of sixty-two years or attaining the age of sixty-two years within six months from the date of publication of these amendment rules in the Official Gazette, may exercise their option in regard to their posting to Teaching, Clinical, Patient Care, Implementation of Health programmes, Public Health programmes and functions including advisory and consultancy as specified in sub-clause (i), within a period of thirty days from the date of the commencement of the Fundamental (Second Amendment) Rules, 2018.

(iii) The serving doctors who fail to exercise the option in regard to their posting to Teaching, Clinical, Patient Care, Implementation of Health programmes, Public Health programmes and functions including advisory and consultancy as specified in sub-clause (i), within the period specified in sub-clause (ii), shall be superannuated from their service on attaining the age of sixty-two years or on expiry of a period of thirty days from the date of the commencement of the Fundamental (Second Amendment) Rules, 2018, whichever is later. "

OFFICE MEMORANDUM

**SUBJECT: FUNDAMENTAL (SECOND AMENDMENT) RULES, 2018 - OPTION TO BE SUBMITTED BY CHS AND DENTAL DOCTORS TO SERVE THE GOVERNMENT UPTO 65 YEARS - REG.**

- The undersigned is directed to forward herewith the Department of Personnel and Training's notification No.GSR 767(E) published in the Gazette of India dated 11.08.2018 vide which the age of superannuation in respect of the doctors belonging to Central Government and Central Government entities including Central Health Service (CHS) and dental doctors under the Department of Health and Family Welfare shall be 62 years unless they exercise the option of posting to teaching/ clinical/ patient care/implementation of health programmes/ Public Health Programmes and functions and other areas/functions including advisory and consultancy etc. depending on their expertise and experience as decided by the competent authority from time to time, in case they desire to continue in their service upto the age of 65 years.
2. In pursuance to the above mentioned notification, it has been decided that the option in the prescribed format may be submitted by the doctors of Central Health Service and dental doctors under the Department of Health and Family Welfare who have already attained the age of 62 years or attaining the age of 62 years within 6 months from the date of publication of these amendment rules dated 11.08.2018 for their further posting to teaching/ clinical/ patient care/implementation of health programmes/ Public Health Programmes and functions and other areas/functions including advisory and consultancy etc depending on the field of their expertise/experience, in case they desire to continue in the service upto the age of 65 years.
  3. The serving doctors belonging to the CHS and dental doctors of Department of Health and Family Welfare who have already attained the age of 62 years or attaining the age of 62 years within 6 months from the date of publication of these amendment rules dated 11.08.2018 may exercise their option for posting to teaching/ clinical/ patient care/implementation of health programmes/ Public Health Programmes and functions and other areas/functions including advisory and consultancy etc depending on the field of their expertise/experience, within a period of 30 days from the date of commencement of the Fundamental (Second Amendment) Rules, 2018.
  4. The doctors working in Organisations /Hospitals/Institutions, etc. under the administrative control of the Department of Health and Family Welfare, Government of India and meeting the criteria mentioned in para 3 above may furnish their option through their respective Heads of Organisations /Hospitals/Institutions, etc. within the period specified in para 3 above to the Joint Secretary (CHS), Department of Health and Family Welfare, Nirman Bhawan, New Delhi-110001.
  5. The serving doctors belonging to the CHS and dental doctors of Department of Health and Family Welfare who fail to exercise the option with regard to their continuation in service upto 65 years as mentioned in para 3 above shall stand superannuated from their service on attaining the age of 62 years or on expiry of 30 days, as the case may be, from the date of commencement of the Fundamental (Second Amendment) Rules, 2018 dated 11.08.2018 whichever is later.
  6. As this will be an ongoing process, the heads of Organisations, Hospitals / Institutions under the Department of Health and Family Welfare should send the 'option' to be submitted by the doctors who are going to attain the age of 62 years, in the prescribed format 6 months in advance, to this department i.e. to Joint Secretary (CHS), Department of Health and Family Welfare, Nirman

Bhawan, New Delhi. The doctors who fail to exercise the 'option' with regard to their continuation in service upto 65 years as mentioned in para 3 above and within the period specified above, shall stand superannuated from their service on attaining the age of 62 years.

7. The other Ministries/Department etc., concerned with the implementation of the Union Cabinet decision dated 27.06.2018 concerned with the implementation of the decision and are covered by the provisions of FR56(bb) are hereby provided a copy of the notification amending FR56(bb). A copy of **Option Form** prescribed for the doctors of CHS and Dental doctors of MoHFW is enclosed for reference / guidance.
