With the approval of the General Manager/East Coast Railway, the following orders are issued.

- 1) Shri N.B. - 5) Shri Sumanta Behura, Gr.B/Elect. presently working as ADEE(TRD)/KUR is posted as ADEE(Gen.-II)/KUR against the Jr. Scale post as mentioned at (4) above.

NB: The empanellment of Shri N.B. Nagendra Rao, SSE/RE/GNT for his appointment/promotion to the post of AEE in Group-B/Elect. service in E.Co.Railway has been approved by the General Manager/ E.Co.Railway on 24.09.2018 and is in terms of PCPO/ECOR's Memorandum No.ECOR/Pers/Gaz/ Elect./AEE-70%/Select Panel/2015-17 dated 26.09.2018. His promotion is subject to his not undergoing any punishment under the RS D&A Rules, 1968.
