Ref: Board's letter of even number dt. 03.05.2011

Apropos Railway Board's referred letter on the aforementioned  
subject specifying therein rates of Camp Allowance etc.

2. Ministry of Defence vide their letter No. 20(1)/2017/D(GS-III) dt. 21<sup>st</sup>  
September 2017, has decided that the Camp Allowance and TA Bounty applicable  
for Territorial Army shall be merged into a single allowance to be called Territorial  
Army Allowance and will be payable at the following rates:

Sl. No.	Category of Employees	Amount (in Rs./annum)
1.	Officers	2000
2.	JCOs	1500
3.	OR	1000

These rates shall automatically increase by 25% each time the Dearness  
Allowance rises by 50%.

100% of the amount of Territorial Army Allowance shall be granted for  
completing full training and 75% of the amount will be granted for completing more  
than 80% of the training.


These orders shall take effect from 01<sup>st</sup> July, 2017.

3. In view of above, Ministry of Railways (Railway Boars) has decided that in  
partial supersession of para (b) of Board's letter of even number dt. 03.05.11, the  
rates of Camp Allowance (to be known as Territorial Army Allowance) shall be  
payable to Railway TA Personnel with effect from 1.07.2017 as per terms and  
conditions laid down vide M/o Defence's aforementioned letter, a copy of which is  
enclosed for information and compliance.

4. Payment of past arrears is subject to production of necessary proof by the TA  
personnel of having satisfied the conditions as prescribed.

5. The expenditure is chargeable to Demand no. 12-Head K 621 and should be met from within the existing allotment.






(b) Camp Allowance


