Sub: Running of freight trains on CC+8 routes.

Ref: Rates Master Circular/PCC/2015/0 dated 19.10.2015 and Corrigenda thereto circulated vide CCM/ECOR's Commercial Circular No.136(G)/2015 dated 20.10.2015 and Corrigenda thereto..

1. Please refer to Annexure II and Annexure-III to Rates Master Circular under reference wherein list of excepted CC+6 Routes and CC+8 routes are prescribed respectively. Now, sanction of the Central Government is hereby accorded to exclude route from the list of excepted CC+6 Routes and include routes in the list of CC+8 routes as under.
