Commercial Circular No: 143(GC) Parcel / 2018

Sub: Revision of freight charges for transportation of all animals including wild animals & birds in Parcel Vans and Brake vans.

Ref: Board's Freight Marketing Circular No. 07 of 2016 dated 27.06.2016 and No. 03 of 2017 dated 17.03.2017 (This office CC No. 54(GC)/Parcel/2017 dated 31.03.2017 & No.12 of 2017 dated 09.10.2017 (This office CC No. 163(GC)Parcel/2017 dt 12.10.2017) & No. 02 of 2018(This office CC No. 16(GC)/Parcel/2018 dt 29.01.2018).

An extract of the Railway Board's letter No. TC.II/2080/12/Livestock dt 06.07.2018(Freight Marketing Circular No.19 of 2018) is reproduced below for information & necessary action:-

"Vide Freight Marketing Circular No. 07 of 2016 dated 27.06.2016, charges for transportation of all animals including wild animals & birds in Parcel vans and Brake vans were revised w.e.f 15.07.2016 from Scale- 'L'+25% to 'L'-Scale irrespective of the category of trains. The revised charges were initially applicable upto 30.03.2017 and after review, further extended from time to time, last being upto 30.06.2018 vide FM Circular No.02 of 2018 dated 24.01.2018.

2. The matter has been reviewed and the Ministry of Railways have now decided to extend the validity of the instructions dated 27.06.2016 for a further period of six months i.e. upto 31.12.2018.

3. No free allowance shall be permissible in case of booking of animals/birds as luggage.

4. Apart from above other charges like development charge, GST etc shall be levied separately as per the instructions notified from time to time.


5. Other terms and conditions for booking of animals including wild animals/birds will remain the same.

6. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.

7. Necessary instructions may be issued to all concerned".
