Vizag General Cargo Berth Pvt. Ltd. siding inside Visakhapatnam Port served by Simhachalam North (SCMN) & Duvvada (DVD) station over WAT Division is hereby notified for charging of freight on through distance basis.

The Alpha code of Vizag General Cargo Berth Pvt. Ltd. siding inside is VGSD and Numerical Code is - "12337739".


The chargeable distance for the traffic booked from/to the siding via Simhachalam North & Duvvada station will be reckoned as follows:

1. **Simhachalam North + 13.00 Km** (Simhachalam North plus Thirteen kilometers).
2. **Duvvada + 20.94 KM** (Duvvada plus Twenty decimal Nine Four kilometers).

Permissible free time for handling traffic at VGSD will be EOL free time.

In case, any additional shunting operation is performed by Railway Locomotive inside the siding, necessary shunting charges will be levied as per extant rules.

All concerned to note and act accordingly.


