
- 1.0 Please refer to Annexure III to Rates Master Circular under reference wherein list of CC+8 routes is prescribed. Now, sanction of the Central Government is hereby accorded to include following routes in the list of already identified CC+8 routes.

Railway	Name of Route
WR	Ex Dry Bulk Terminal Tekra (DBTK) – Gandhidham (GIM)
ECoR	Bye Pass Line between Sukinda Road to Jajpur Keonjhar Road (avoiding Jakhapura) (KUR Division)
ECoR	Lanjigarh to Junagarh Road (SBP Division)

- 2.0 All other details of the Rates Master Circular & Corrigenda thereto under reference will continue to apply unchanged.
- 3.0 These instructions shall come into effect from **14.10.2018** and shall remain valid till further advice.


