Sub: Restriction of loading & unloading at NDLS, DLI & ANVT station for Deepawali & Chhath Pooja rush arrangements.

Ref: SCM/Rates/Northern Railway's Ir. No. 1329-R/Opening & Closing/2018 N.R.B.H.NDLS, dt 25.10.2018 (Northern Railway Rates Opening/Closing circular No. 17 of 2018(Case no. 1329-R/O&C/2018 dt 25.10.18).

An extract of SCM (Rates) / Northern Railway's letter under reference is reproduced below for information & necessary action:-

"Competent Authority has accorded approval for imposition of restriction on all types of parcel activities (including handling leased SLRs, AGCs, VPs & demand VP) and loading and unloading strictly prohibited from **05.11.2018 to 12.11.2018** in Delhi area (i.e. at **NDLS, DLI & ANVT** stations) of Delhi Division. This restriction is also applicable for passing trains originating from other zones/divisions and having stoppage in Delhi area for loading / unloading. However, personal luggage may be allowed in the passenger coach only and booking of registered newspaper/magazines shall be permitted after observing all commercial formalities.

The stacking of Parcels at platforms and cross movement of the trolleys from one end of the platform to another end is strictly prohibited from **05.11.2018 to 12.11.2018** at **NDLS, DLI & ANVT** stations."

All concerned may be advised for strict compliance.
