Sub: Adjustment in Base Freight Rates – Classification of Commodities.

Ref: Board's letters No.TCR/1078/2015/07 dated 20.03.2015 and No.TCR/1078/2018/15 dated 31.10.2018 circulated vide Commercial Circular No.31(G)/2015 dated 23.03.2015 and 206(G)/2018 dated 01.11.2018 respectively.

With reference to Board's letter dated 20.03.2015 notifying adjustment in Base freight rates with effect from 01.04.2015, it is clarified that "Vanaspatti Ghee" appearing in Group No.11(a) under the Main Commodity Head – Hydrogenated and other Edible Oils at Page No.14 of Goods Tariff No.48 Part-1 (Vol.II) shall be chargeable at Class LR-3(A) in Trainload and LR-3 (B) in Wagonload in terms of Board's Rates Circular No.19 of 2018 dated 31.10.2018 {Commercial Circular No. 206(G)/2018 dated 01.11.2018} when loaded in covered wagons.

This clarification shall come into force w.e.f. **16.11.2018** till further advice.

This issues with the concurrence of the Finance Directorate of the Ministry of Railways.
