Sub: Rates for Automobile Traffic carried on NMG/BCCNR and BCACM wagons.

Ref: Board's Rates Circular No.19 of 2016, 17 of 2017 and 11 of 2018 dt.31.05.2018, CCM/ECOR's Commercial Circular No. No.80(G)/2016 dated 08.06.2016, 79(G)/2017 dated 24.05.2017 and 104(G)/2018 dated 01.06.2018 respectively..

1. In terms of Rates Circular No.11 of 2018 dated 31.05.2018, the freight rates for Automobile Traffic when moved in NMG, BCCNR and BCACM wagons were revised and notified for the period from 01.06.2018 to 30.11.2018.
2. The matter has been reviewed by Board and sanction is accorded to extend the present rates for Automobile Traffic, when moved in NMG, BCCNR and BCACM wagons for another one year w.e.f. 01.12.2018 to 30.11.2019.
