Indian Railway officers are deputed to attend the Advanced Leadership Programme/Advanced Strategic Management Programme at the Carnegie Mellon University, Pittsburgh under the Contract with them. The officers deputed to this programme are treated as being "On Duty".

Any expenditure incurred by the officer on transportation not provided for by the Embassy of India/Consulate General of India in USA or by Carnegie Mellon University, Pittsburgh/USA i.e. not included in the Contract, during the training period, undertaken directly in connection with the subject training, may be reimbursed to the officer as per their entitlement and for the shortest route on submission of original receipts of the expenditure incurred. It may also be ensured that such claims should be vetted by the associate finance of concerned Head Quarters.
