Commercial Circular No.228(G)/2018

Sub: Rates of Demurrage in the case of Coal and/or Coke consignment.

Ref: Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0 and its corrigenda, circulated vide CCM/ECOR's Commercial Circular No. 65(G)/2016 dated 20.05.2016 and its corrigenda.

Please refer to Para 3.0 of Chapter-I of the Rates Master Circular under reference regarding rates of Demurrage Charge.

The matter has been reviewed and it has been decided to prescribe separate slab of Demurrage rates in the case of rake of Coal and/or Coke consignment by incorporating an additional Para 3.1.1 in Chapter-I of the above-mentioned Rates Master Circular, as under:

"3.1.1 In the case of rake of Coal and/or Coke consignment, Demurrage Charge will be levied as per the rates given below:

Duration of excess detention (i.e. detention beyond permissible free time)	Rates of Demurrage Charge
Upto 4 hours	2 times of the base rate (At present, base rate is Rs.150/- per wagon per hour or part of an hour)
Beyond 4 hours & upto 8 hours	2.5 times of the base rate
Beyond 8 hours	3 times of the base rate

Further, existing provision regarding imposition of Penal Demurrage upto six times of the prevalent base rate shall continue to be applied for the terminals which consistently perform badly."

These instructions will come into force with effective from **08.12.2018**.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Railway Board.

All concerned to note and act accordingly.
