(ii) Consequently, the additional charge given to DMM/WAT to look after the duties of the post of AMM/WSD/VSKP vide PCPO/ECOR's office order No.148/2018 dated 29.10.2018 is terminated.
- NB: The Sr.Scale panel/Select list of Shri Vikas Kumar, JS/IRSS for his promotion to Sr.Scale on ad-hoc basis has been approved by the General Manager/E.Co.Railway on 25.05.2018. He is entitled to draw prescribed charge allowance as applicable on promotion to Sr.Scale (ad-hoc) till he completes four years' regular service. Thereafter, His fixation of pay will be made in Sr.Scale under normal operation of rules.
