Sub: Hub & Spoke policy for movement of container trains

Refer Railway Board's letter No.2012/TT-III/73/9 Vol.II dated 28.12.2017 & 15.01.2018 (PCCM/ECOR's Commercial Circular No. 01(G)/18 dt 01.01.18 & 10(G)/18 dt 16.01.18) for movement of EXIM and Domestic Container trains under Hub & Spoke policy. The Container Train Circular No.11/2017(PCCM/ECOR's Commercial Circular No. 01(G)/18 dt 01.01.18) was extended for the period of one year i.e from 01.01.2018 to 31.12.2018 and Container Train Circular No.01/2018(PCCM/ECOR's Commercial Circular No. 10(G)/18 dt 16.01.18) was extended for the period of one year i.e from 17.01.2018 to 31.12.2018.

Now as it is necessary to do so in the public interest, the validity of these container train circulars is hereby extended till further advise unless modified/cancelled earlier.

A detailed review may further be conducted on six monthly basis by Divisions about trends of traffic on the said sectors for taking a holistic view and decision in the matter.

All other instructions issued vide letter under above references will continue to hold good.
