Government – Annual Allowance.

Consequent upon the decisions taken by the government on the recommendations of the  
Seventh Central Pay Commission relating to revision of allowances & issued vide MoH&FW OM No.  
A.45012/03/2017-CHS.V dated 30.08.2017, officers of the Indian Railway Medical Service(GDMOs) will  
be granted Annual Allowance as detailed below:

Annual Allowance

S. No.	Category	Revised Rates
1.	Railway doctors having Post Graduate qualification recognised under Indian Medical Council Act, 1956.	₹ 2250/- p.m.
2.	General Duty Doctors who do not possess any P G qualification or who possess unrecognised P G qualification.	₹ 1350/- p.m.

These revised rates of Annual Allowance will be subject to the following condition:

'At the end of financial year, each Specialist/General Duty Medical Officer will be required to furnish a certificate to the effect that the amount of Annual Allowance has been utilized for the purpose it was drawn. In the case of retirement/resignation before the end of the financial year, such a certificate will be furnished at the time of such retirement/resignation.'

2. The rates of this allowance will further rise by 25 percent each time DA payable or revised pay scales rises by 50 percent. The revised rates of the allowances shall be admissible with effect from the 1<sup>st</sup> July, 2017.
3. The terms & conditions as contained in para 1426 of IREC Vol.II (Sixth Edition – 1987, Second Reprint Edition – 2005, will remain unchanged.
4. This issues with the concurrence of the Finance Directorate of the Ministry of Railways.


